



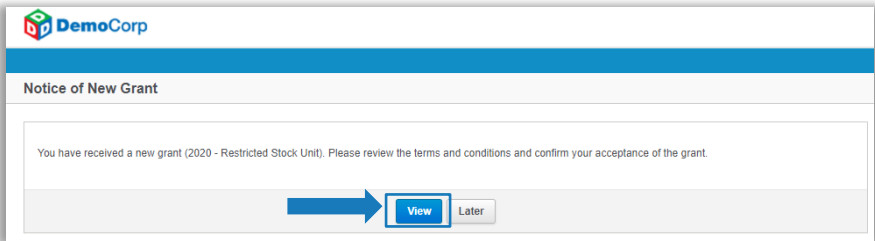
How Do I Accept a Grant

To accept a grant, complete the following steps in your stock plan account.

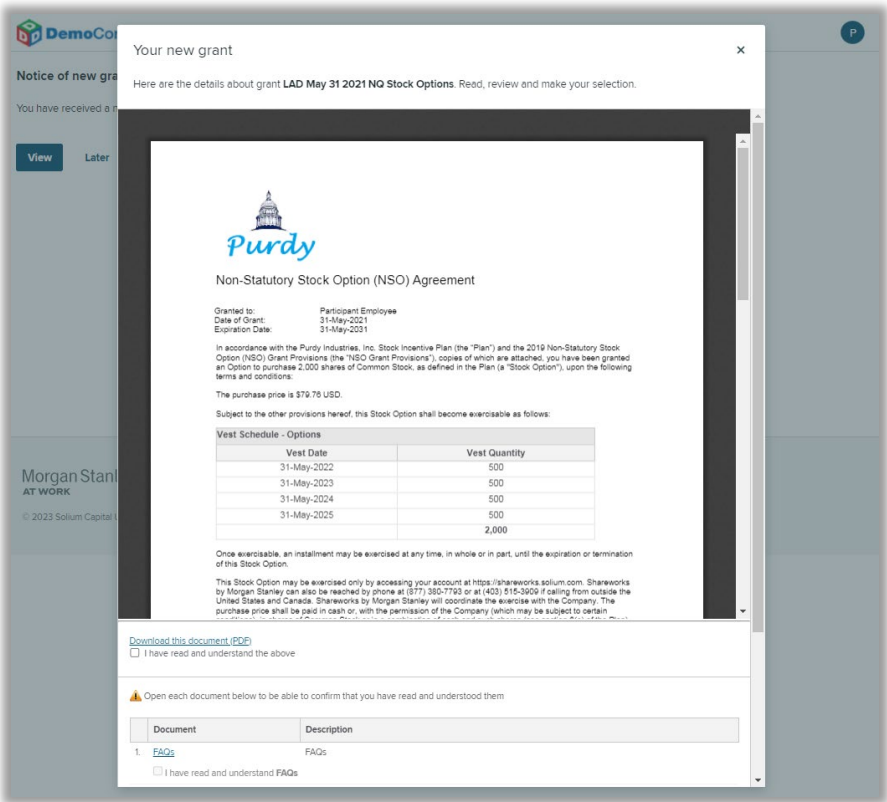
1. Login
