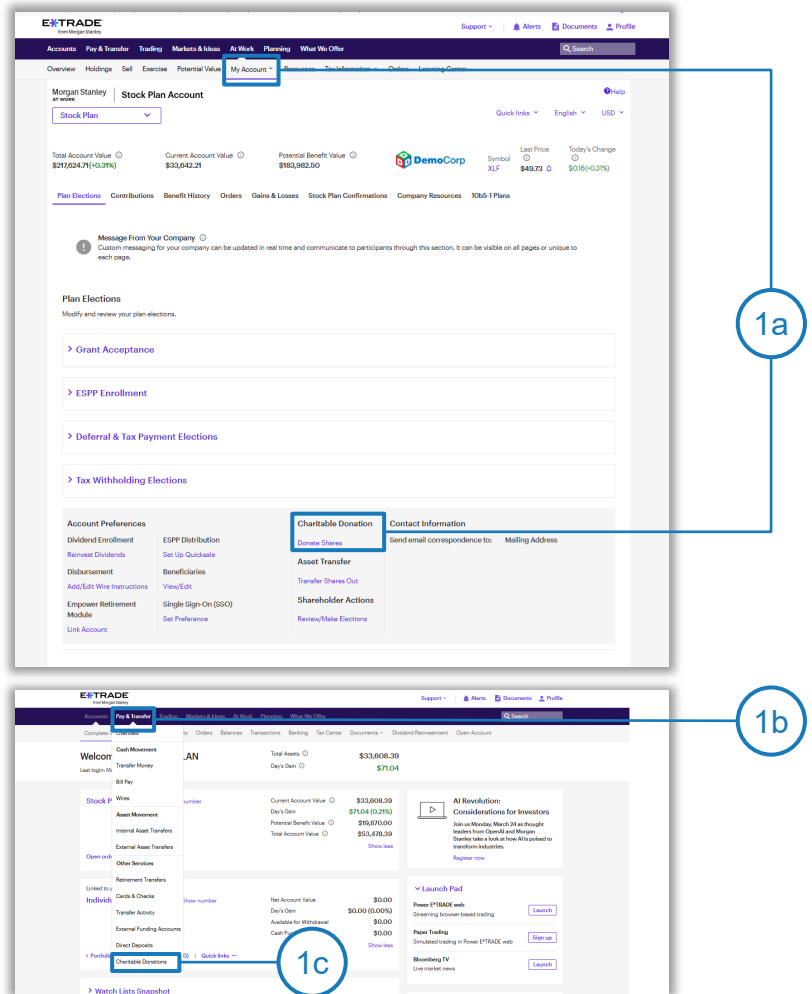
## Donating Shares on etrade.com

To get started donating your shares, go to the [Charitable Donations](#) page on etrade.com and follow the steps on the screen. You can also follow this step-by-step guide for detailed instructions.

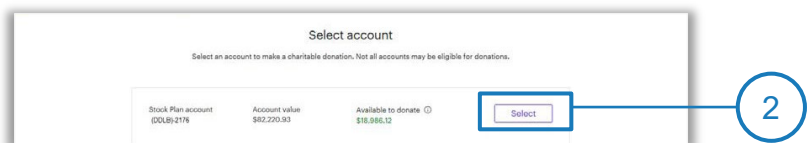
- Once logged on, in the **At Work** portion of your account, (1a) click on **Donate Shares** at the bottom of the **My Account** page

OR

If you do not have an At Work portion, hover over the (1b) **Pay & Transfer** tab found on the navigation bar then select (1c) **Charitable Donations**.



- Click **Select** next to the account from which you would like to donate
  - NOTE:** If there are multiple eligible accounts, each eligible account will be shown. You can only select one at time, provided there are shares available to donate.
